**THE COURT FINDS** defendant has been advised of, fully understands, and voluntarily waives all constitutional and statutory rights to a speedy trial. The Court further finds defendant is a person who consents to and would benefit from a grant of diversion pursuant to Penal Code section 1001.95.

**THEREFORE, IT IS ORDERED THAT** diversion is granted for  6 months  12 months  \_\_\_\_\_ months, but no longer than 24 months on condition defendant obey all of the following terms and conditions:

1. Participate in and complete the following programs:
  - Theft Awareness Program
  - Twelve (12) Anger Management Sessions

  - Residential substance use treatment program per assessment

2. Submit your person and property to search and seizure upon official demand without probable cause or reasonable suspicion for:
