Signage:

- Signage at each public entrance of the facility to inform all employees and customers that they should: avoid entering the facility if they have a cough or fever; maintain a minimum six-foot distance from one another; sneeze and cough into a cloth or tissue or, if not available, into one's elbow; and not shake hands or engage in any unnecessary physical contact
- Signage posting a copy of the Social Distancing Protocol at each public entrance to the facility

Measures To Protect Employee Health (check all that apply to the facility):

- Everyone who can carry out their work duties from home has been directed to do so.
- All employees have been told not to come to work if sick.
- Symptom checks are being conducted before employees may enter the work space.
- All desks or individual work stations are separated by at least six feet
- Break rooms, bathrooms, and other common areas are being disinfected frequently, on the following schedule:
 - Break rooms: Sink areas and kitchen areas will be cleaned after each use.
 - Bathrooms: Cleanliness to be maintained throughout the day: sink areas and door handles to be cleaned after each use; janitorial staff to clean after hours.
 - Other: Shared office equipment; copiers, printers, door handles, buckets to be cleaned by employees throughout the day: Mid-morning (10:00 am), Mid-day (noon), Mid-afternoon (2:00 pm), End of day (4:00 pm)
- Disinfectant and related supplies are available to all employees at the following location(s); in each courtroom, Criminal/Traffic office area, and Civil office area
- Hand sanitizer effective against COVID-19 is available to all employees at the following location(s):
 - Criminal/Traffic office area
 - Civil office area

Mounted on walls at entrances and throughout the building. Personal size hand sanitizer available to all employees at work.

- Soap and water are available to all employees at the following location(s):
 - Criminal/Traffic office area: restrooms and sink in break room
 - Civil office area: restrooms and sink
 - Lobby: restrooms
- Copies of this Protocol have been distributed to all employees.

Optional—Describe other measures:

Measures To Prevent Crowds From Gathering (check all that apply to the facility):

- Limit the number of customers at any one time to;
- 17 people in courtroom Dept. 1 (5 court staff and 10 people in the audience, 2 legal counsel)
 - 20 people in courtroom Dept. 2 (5 court staff and 13 people in the audience, 2 legal counsel)
 - 10 people in security lobby
 - 2 people at payment windows (plaza side)
 - 49 people total in spaces made available to the public

which allows for customers and employees to easily maintain at least six-foot distance from one another at all practicable times.

Bailiff to ensure that the maximum number of customers in the facility set forth above is not exceeded.

Measures To Keep People At Least Six Feet Apart (check all that apply to the facility)

Placing signs outside the court buildings reminding people to be at least six feet apart, including when in line.

Placing tape or other markings at least six feet apart in customer line areas inside the store and on sidewalks at public entrances with signs directing customers to use the markings to maintain distance.

All employees have been instructed to maintain at least six feet distance from customers and from each other, except employees may momentarily come closer when necessary to accept payment, deliver goods or services, or as otherwise necessary.

Hand sanitizer, soap and water, or effective disinfectant is available to the public at or near the entrance of the facility.
